AND ALL OWNERS, OFFICERS, MEMBERS, AFFILIATED ORGANIZATIONS, LAND OWNERS, AGENTS AND/ OR EMPLOYEES FOR ANY INJURY OR DEATH CAUSED BY OR RESULTING FROM MY/OR MY FAMILY'S PARTICIPATION IN THESE ACTIVITIES. THIS CONTRACT SHALL BE LEGALLY BINDING UPON MY HEIRS, MY ESTATE, LEGAL GUARDIANS, MY PERSONAL REPRESENTATIVES AND ME.
